APPLICATION FOR ADMISSION 2012-2013

Please complete all information on the back and return completed application to Washington Math Science Technology Public Charter High School either in person between 8am and 4pm, Monday through Friday or via email to admissions@wmstpchs.net. You can also submit your application on line at wmstpchs.org.

The application period will begin December 12, 2011 and end on **March 2, 2012**. If we receive more applications than spaces available, we will conduct a public lottery on **March 16, 2012**. Applicants will be notified by March 26, 2012. Students who submit an application after March 2, 2012 will be considered for admissions based on the availability of space.

CRITERIA FOR ADMISSION:

- ❖ Students must have completed 8th grade to enter 9th grade, or meet all applicable transfer credit requirements to enter 10th, 11th or 12th grade.
- ❖ Students must live in the District of Columbia and provide specific documents to verify residency.
- ❖ Students must submit a complete application.
- ❖ Student and parent/guardian must participate in an Admissions Workshop.

APPLICATION INSTRUCTIONS:

- ❖ The application is to be completed by the applicant's parent/guardian.
- ❖ Upon completion, application should be either hand-delivered to the address below or sent via email to admissions@wmstpchs.net.
- ❖ Applicants will receive notification of receipt of applications.
- ❖ Notification of acceptance will be sent at the close of the application period.
